The work of this project includes the construction of approximately 1-82 GPM Duplex Submersible Non-Clog Pump Station with Standby Power; 2600 LF 8" dia. Sanitary Sewer; 11 EA 4.0' dia. Manholes; 1950 FT 4" dia. SDR-21 Force Main; 120 LF 8'-16" Steel Casing Dry Bored and Jacked; 14 EA Tree Removals; 26 EA 4" dia.
